

ONTARIO ROWING ASSOCIATION MINUTES OF THE ANNUAL GENERAL MEETING – November 25, 2017

Mississauga, Ontario

1. CALL TO ORDER

Chris Waddell – ORA President called the meeting to order at 8:15 AM. A moment of silence was held in respect of Ontario rowing personnel and supporters who passed away this past year.

2. QUORUM, MAJORITY, APPOINTMENT OF SCRUTINEERS

Chris Waddell reported that a quorum existed, and that with 53 of 64 voting members in attendance or by proxy, a majority will be 27 votes. Lynda Dundas of Don Rowing Club and Dean Hay of North Bay Rowing Club were appointed as Scrutineers.

7. ANNUAL REPORT

Annual Report

Andrew Backer presented the Annual Report. His report included:

- New Board approved 2017-2020 <u>Leading Change Inspiring Excellence</u> Strategic Plan and the overarching goals
 of the new plan Strengthen the operations of the organization; Improve the Association's governance;
 Modernize ROWONTARIO's business model.
- Highlights and "lowlights" from 2017
- Goals for 2017/18:
 - Develop Board Governance Manual following the new By-laws
 - o Update operational policies align with best practices for not-for-profits
 - Establish a long-term financial model/plan
 - Establish a long-term communication strategy
 - Develop club resources for athlete development programs at the L2T, T2T and T2C stages of the athlete pathway
 - Launch a new High-Performance plan/program
 - Prepare a 2021 Team Ontario identification plan
 - O Develop an implementation plan for mandatory coach certification
 - Launch Phase 2 of the Remote Coach Network Project
 - Deliver the Umpire Training Conference
 - o Develop a standardized umpire reimbursement policy
 - Launch a revitalized ROWONTARIO Championships and ROWONTARIO Masters Championships
 - o Develop new ROWONTARIO property events

8. FINANCIALS

8.1 2016/17 Audited Financials

Barkwell noted that there are several levels of reviews of the finances of the Association: the Finance Committee, the Board and the auditors. He reviewed the financial statements and the year to date financial report, and the "clean" audit opinion. He reported that internally designated funds with the exception of the Claude Saunders Fund, have been consolidated, to align with direction from the Ministry of Tourism, Culture and Sport.

8.3 2017/18 – 2nd Quarter Financial Statements (ending Sep 30th, 2017)

Backer reviewed the Year to Date and Fiscal Year-End projections for the 2017/18 fiscal year. The Association is projecting a deficit of about \$63,649 compared to the budgeted deficit of \$231,000. Backer explained to members that the deficit would be covered by reserves.

9. ELECTION OF DIRECTORS

The slate of three Directors, Pippa Hobbes, Jurgen Schubert, and Judy Sutcliffe were acclaimed and will join the Board of Directors with Chris Waddell – President, Margy Braga – Director, Anthony Miller – Director and Amanda Schweinbenz – Director.

10. ROWING CANADA – NATIONAL TRAINING CENTRE

Phil Monckton spoke to his proposed motion. Highlights included:

- The comparison between the bodies of water (Elk Lake and Fanshawe Lake).
- The concern that RCA may not have done due diligence before making the decision to move the London Training Centre (LTC) staff and athletes to Victoria B.C.
- The scope of work for the "environment scan" was not completed yet, nor has a contractor been hired to conduct such a scan, but the promise was that the scan will be completed by the end of 2017.

Other discussion:

- RCA's rationale for the move west was to allow rowers to row 365 days a year experts advised that research shows that it is not necessary to row 365 days a year; in fact top performing nations do not use this approach.
- Concerns raised that this decision was not just a decision against London, but also rowing in Ontario.

MOTION:

That the ROWONTARIO President be directed to move at the RCA annual meeting: "That RCA continue to fully support and operate the London National Team Training Centre until a Long Term Strategic Plan, which addresses national team athlete training centres, has been reviewed by the membership and approved by the RCA Board. This Strategic Plan should take into consideration input from the environmental scan to be commissioned and conducted by RCA.

11. RCA RULES OF RACING - Proposed amendments

Tom Blacquiere of CSSRA, raised concerned about RCA's proposed change to Rule 2.10, re: LTW rowing, to remove LTW rowing for U19 athletes. He acknowledged that there are abuses, with junior rowers engaging in unsafe weight loss practices, but argued that removing U19 LTW rowing from the Rules was not the way to address such abuses. He reported the need to work with other stakeholders to protect athletes who are being abused, and to provide safe options for unmonitored athletes regarding safe weight loss. CSSRA is opposed to the proposed Rule as it is worded in the Rules consultation document and requested that the ROWONTARIO President be directed to vote against adding such a Rule at the RCA Semi-Annual meeting.

MOTION:

That the ROWONTARIO membership direct the President of ROWONTARIO to vote against the proposed change to the RCA Rules of Racing that would prohibit LTW rowing for U19 athletes.
