## 1. CALL TO ORDER

## 2. ROLL CALL, QUORUM, MAJORITY, APPOINTMENT OF SCRUTINEERS

A roll call was conducted. Chris Waddell reported that a quorum existed, and that with 55 of 68 voting members in attendance or by proxy, a majority will be 28 votes.

On a motion duly made by CSSRA and seconded by London RC be it resolved that Stephen Ross and Andrew Smith be appointed as Scrutineers for the 2019 Annual General Meeting. CARRIED

## 3. APPROVAL OF THE AGENDA

On a motion duly made by Notre Dame RC and seconded by Western Middlesex RC, be it resolved that the Agenda is approved as presented. CARRIED

## 4. APPROVAL OF MINUTES - 2018 ANNUAL GENERAL MEETING

The minutes of the 2018 Annual General Meeting of the Association were reviewed.

On a motion duly made by Durham RC and seconded by Ottawa RC, be it resolved that the Minutes of the 2018 Annual General Meeting of the Ontario Rowing Association held on December 1<sup>st</sup> are approved as presented. CARRIED

#### 5. BUSINESS ARISING FROM THE MINUTES

There was no business arising.

#### 6. AMENDMENT TO THE BYLAWS

Judy Sutcliffe, Chair, ROWONTARIO Governance Committee, provided an overview of the reason for the addition to section 2.01 or (b) and (d) and reviewed the contents of the section.

On a motion duly made by South Niagara RC and seconded by St. Catharines RC, be it resolved that the addition to the By-laws of section 2.01 (a) and (d) that describe the length of terms of the Directors be approved. CARRIED

	d. Notwithstanding the preceding, for the purposes of	
	transition to a rotating board:	
	i. at the Annual Meeting in 2019, the	
	Members shall elect three (3) Directors each for a three (3) year term (i.e. to the Annual Meeting in	
	2022 ((at which meeting they will be eligible for re-	
	election in accordance with (c) above));	
2.01 Election and Term	ii. at the first (1st) Board meeting after the	
	Annual Meeting in 2019, the Board shall by secret	
	ballot conduct the following vote (the "Vote")	
	regarding the four (4) current Directors whose	
	term is set to expire at the Annual Meeting in 2020	
	(the "Four Directors"):	
	a. the two (2) of the Four Directors	
	with the most number of votes in the Vote	
	shall have their term of office extended by	
	one (1) year to the Annual Meeting in 2021 (at which meeting they will be eligible for	
	re-election in accordance with (c) above);	
	and	
	b. the two (2) of the Four Directors	
	with the least number of votes shall have	
	their term of office expire at the Annual	
	Meeting in 2020 as originally scheduled (at	
	which meeting they will be eligible for re-	
	election in accordance with (c) above).

On a motion duly made by Ottawa RC and seconded by CORA, be it resolved that the Unaudited Financial Report for the period April 1, 2019 to September 30, 2019 be received as presented. CARRIED

#### 9. ELECTION OF DIRECTORS

Two of the three new directors (Meredith Smith and Janet Lancaster) briefly addressed the membership. The third new director had another commitment and had left the meeting.

On a motion duly made by CSSRA and seconded by London RC, be it resolved that the members nominated to serve as director, Dan O'Shaughnessy, Meredith Smith and Janet Lancaster be acclaimed. CARRIED

## 10. RECOGNITION OF OUT-GOING DIRECTORS

Chris Waddell recognized the retiring directors: Judy Sutcliffe, Jurgen Schubert and Pippa Hobbes and provided each with a token of appreciation.
